TERMS & CONDITIONS

WHAT'S INCLUDED IN YOUR CERTIFICATE:

1. During the initial year after the date specified on the front of the certificate the "Certificate" entitles the holder to book up to 2 guests in a X room. This Certificate also covers governmental and quasi-governmental taxes and hotel/service fees. Gratuities are at the guest's discretion and are not included. The Certificate cannot be used to pay alcoholic beverages, retail and spa products/services.

At the sole discretion of Hacienda AltaGracia, Auberge Resorts Collection, the Certificate may also be used for different lengths other than noted on the "Certificate" face (prices provided at time of booking). That value amount shall be applied to the hotel selected and booked and the redeemer must pay the difference in rate to Hacienda AltaGracia, Auberge Resorts Collection in full at the time of booking. If the Certificate is being used for an upgraded room category, the Value amount shall be applied and the redeemer must pay the difference in rate to the Hacienda AltaGracia, Auberge Resorts Collection at the time of booking. In all cases, if the Value exceeds the rate for the specific hotel and room category splected, the difference shall be forfeited. Hacienda AltaGracia, Auberge Resorts Collection at the time of booking. hotel and room category selected, the difference shall be forfeited. Hacienda AltaGracia, Auberge Resorts Collection at the time of the booking request will provide the lowest fare publicly available for which the redeemer qualifies, including available promotional rates unless otherwise expressly provided in the terms and conditions for that

This "Certificate" may be supplemented with other acceptable forms of payment toward room upgrades and/or guest

The Certificate cannot be used to purchase hotels offered by any other entity, whether affiliated with Hacienda AltaGracia, Auberge Resorts Collection or not. This "Certificate" cannot be used and is not applicable towards a room block that has been purchased by a third party and is then being resold, nor for a room that is included as part of a group booking or full resort buyout made with Hacienda AltaGracia, Auberge Resorts Collection.

2 After the Initial 1 Year Period

A. IN LIEU OF THE PROVISIONS OF "1. During the Initial 1 Year Period", AT ANY POINT AFTER THE END OF THE INITIAL 1 YEAR PERIOD FOR A CERTIFICATE, THE CERTIFICATE SHALL BE GIVEN A SPECIFIC DOLLAR VALUE (BASED ON THE FACE VALUE OF THE CERTIFICATE AS SPECIFIED BY THE HOTEL IN ITS ANNUAL PRICING GRID FOR CERTIFICATES IN EFFECT AT THE TIME OF PURCHASE OF THE CERTIFICATE (hereinafter the "Face Value"). THAT FACE VALUE CAN BE APPLIED AGAINST THE COST OF ANY Hacienda AltaGracia, AUBERGE RESORTS COLLECTION.

B. PAYMENT OF ANY OUTSTANDING BALANCE. ANY OUTSTANDING BALANCE DUE AFTER APPLICATION OF THE FACE VALUE MUST BE PAID AT THE TIME OF THE BOOKING. IF THE FACE VALUE EXCEEDS THE COST OF THE RESORT STAY, THE DIFFERENCE SHALL NOT BE REFUNDED OR CREDITED.

REDEEMING YOUR CERTIFICATE

To Redeem Your Certificate, You Must:

- 3. Requested travel dates and room category may be capacity controlled and is subject to actual availability. Certificates may be upgraded at the Certificate holder's expense. President's Day Weekend, Annual Closure, Spring Break and Festive Season are blackout dates for all Certificate Levels.
- 4. By purchasing/redeeming this "Certificate," the purchaser/holder agrees to be bound by all Hacienda AltaGracia, Auberge Resorts Collection cancellation terms and conditions. Cancellations for reservations must be received at least 14 days prior to arrival date. Cancellations within 14 days prior to arrival will result in all deposits/certificate value forfeited. Cancellations made 14 days or more in advance of arrival will result in a cancellation of the booking with no penalty; the certificate can be redeemed for a future stay.
- 5. Hacienda AltaGracia, Auberge Resorts Collection's other policies as well as terms and conditions shall also apply. Maximum occupancy per room is for 2 adults. Any additional person six years and older in the same room is subject to the additional child/adult fees.
- 6. This "Certificate" is transferable only when gifted. This "Certificate" is void if sold for cash or other consideration. Any tax liability, connected with the receipt or use of this "Certificate" is the sole responsibility and liability of the person giving or receiving the Certificate; not "name of supplier".

EXPIRATION AND CHARGES. Your Hacienda AltaGracia, Auberge Resorts Collection Certificate has a one year expiration date. Should this Certificate not be redeemed within one year from date of issuance, the certificate reverts to the value of the certificate at time of purchase. This Certificate has neither an inactive or dormancy fee nor any monthly or other maintenance fee.
