TERMS & CONDITIONS

WHAT'S INCLUDED IN THE CERTIFICATE:

1. During the Initial 2 Years Period

For a period of 2 years after the date specified on the front of the Certificate (the "Initial 2 Years Period"), the "Certificate" entitles the holder to book up to the number of guests in the accommodation category noted on the face of this certificate. This Certificate also covers governmental and quasi-governmental taxes and resort/service fees. Children under the age of 16 are not allowed at the Balneotherapy and at the Indoor Pool.

Use for Non-Specified Length of Stay or Room Category

At the sole discretion of The Oitavos Hotel, the Certificate may also be used for stays of different lengths, upgraded room categories, or accommodations for more guests other than noted on the "Certificate" face (rates provided at time of booking). In the event the "Certificate" is used for any modification other than noted on the "Certificate" face, the value of the Certificate reverts to the fixed dollar amount of the Certificate at time of purchase. The value will shall be applied to the reservation and the redeemer must pay the difference in rate in full to The Oitavos Hotel at the time of booking. In all cases, if the Value exceeds the requested modification, the difference shall be forfeited. The Oitavos Hotel at the time of the booking request will provide the lowest fare publicly available for which the redeemer qualifies, including available promotional rates unless otherwise expressly provided in the terms and conditions for that promotion.

The Certificate cannot be used to purchase hotels offered by any other entity, whether affiliated with The Oitavos Hotel or not. This "Certificate" cannot be used and is not applicable towards a room block that has been purchased by a third party and is then being resold, nor for a room that is included as part of a group booking or full location buyout made with The Oitavos Hotel.

2. After the Initial 2 Years Period

A. IN LIEU OF THE PROVISIONS OF "1. During the Initial 2 Years Period", AT ANY POINT AFTER THE END OF THE INITIAL 2 YEARS PERIOD FOR A CERTIFICATE, THE CERTIFICATE SHALL BE GIVEN A SPECIFIC DOLLAR VALUE (BASED ON THE FACE VALUE OF THE CERTIFICATE AS SPECIFIED BY THE OITAVOS HOTEL IN ITS ANNUAL PRICING GRID FOR CERTIFICATES IN EFFECT AT THE TIME OF PURCHASE OF THE CERTIFICATE (hereinafter the "Face Value"). THAT FACE VALUE CAN BE APPLIED AGAINST THE COST OF ANY FUTURE STAY AT THE OITAVOS HOTEL.

B. PAYMENT OF ANY OUTSTANDING BALANCE.

ANY OUTSTANDING BALANCE DUE AFTER APPLICATION OF THE FACE VALUE MUST BE PAID IN FULL AT THE TIME OF THE BOOKING. IF THE FACE VALUE EXCEEDS THE COST OF THE STAY, THE DIFFERENCE SHALL NOT BE REFUNDED OR CREDITED.

REDEEMING YOUR CERTIFICATE

To Redeem Your Certificate, You Must:

- Contact Reservations at _____ . (This Certificate cannot be redeemed or used in any other manner, including but not limited to, at any travel agency.)
- Provide the following information to the contact above at time of redemption: (i) your name and contact information and (ii) the Certificate ID# on the face of Certificate.
- All guests on the booking must satisfy The Oitavos Hotel's then current minimum age requirements.
 - The Oitavos Hotel will not, under any circumstances, pay a commission in connection with or related to the redemption and/or utilization of this "Certificate."
 - Requested travel dates and room category may be capacity controlled and is subject to actual availability. Certificates may be upgraded at the Certificate holder's expense. Please take into consideration that, per usual, The Oitavos closes in the first and last weeks of each year (the dates may differ, but usually the closing period is between mid-December and mid-January).
 - By purchasing/redeeming this "Certificate," the purchaser/holder agrees to be bound by the following The Oitavos Hotel cancellation terms and conditions: Please note that this Certificate is non-refundable upon purchase. In case of cancellation no reimburse will be made. The dates cannot be modified.
 - The Oitavos Hotel's other policies and terms and conditions shall also apply. Children permitted when staying in the same room with at least one guest aged 18+.
 - Payments made for the "Certificate" are nonrefundable and cannot be redeemed for cash. Lost or stolen Certificates or Certificates used without permission will not be replaced. This "Certificate" has no cash value (\$0).
 - This "Certificate" is transferable only when gifted. This "Certificate" is void if sold for cash or other consideration.
