TERMS & CONDITIONS

WHAT'S INCLUDED IN THE CERTIFICATE:

1. During the Initial 2 Year Period

For a period of 2 years after the date specified on the front of the Certificate (the "Initial 2 Year Period"), the "Certificate" entitles the holder to book up to the number of guests in the accommodation category noted on the face of this certificate. This Certificate also covers governmental and quasi-governmental taxes and resort/service fees. *This certificate does not include purchases from the Three Forks Gift Shop, Premium Wine and Liquor Purchases, Mayo Clinic Health and Wellness Assessments, and Admission to the Three Forks Concert Series.*

Use for Non-Specified Length of Stay or Room Category

At the sole discretion of Three Forks Ranch, the Certificate may also be used for stays of different lengths, upgraded room categories, or accommodations for more guests other than noted on the "Certificate" face (rates provided at time of booking). In the event the "Certificate" is used for any modification other than noted on the "Certificate" face, the value of the Certificate reverts to the fixed dollar amount of the Certificate at time of purchase. The value will shall be applied to the reservation and the redeemer must pay the difference in rate in full to Three Forks Ranch at the time of booking. In all cases, if the Value exceeds the requested modification, the difference shall be forfeited.

Certificates are upgradeable and the difference in price will be the sole responsibility of the recipient. Recipient may also add on a Three Forks Ranch Longevity or Wellness Assessment which is also the responsibility of the recipient.

The Certificate cannot be used to purchase hotels offered by any other entity, whether affiliated with Three Forks Ranch or not. This "Certificate" cannot be used and is not applicable towards a room block that has been purchased by a third party and is then being resold, nor for a room that is included as part of a group booking or full location buyout made with Three Forks Ranch.

2. After the Initial 2 Year Period

A. IN LIEU OF THE PROVISIONS OF "1. During the Initial 2 Year Period". AT ANY POINT AFTER THE END OF THE INITIAL 2 YEAR PERIOD FOR A CERTIFICATE, THE CERTIFICATE SHALL BE GIVEN A SPECIFIC DOLLAR VALUE (BASED ON THE FACE VALUE OF THE CERTIFICATE AS SPECIFIED BY THREE FORKS RANCH IN ITS ANNUAL PRICING GRID FOR CERTIFICATES IN EFFECT AT THE TIME OF PURCHASE OF THE CERTIFICATE (hereinafter the "Face Value"). THAT FACE VALUE CAN BE APPLIED AGAINST THE COST OF ANY FUTURE STAY AT THREE FORKS RANCH.

B. PAYMENT OF ANY OUTSTANDING BALANCE.

ANY OUTSTANDING BALANCE DUE AFTER APPLICATION OF THE FACE VALUE MUST BE PAID IN FULL AT THE TIME OF THE BOOKING. IF THE FACE VALUE EXCEEDS THE COST OF THE STAY, THE DIFFERENCE SHALL NOT BE REFUNDED OR CREDITED.

C. EXPIRATION DATE. IF CERTIFICATE HAS NOT BEEN REDEEMED WITHIN 5 YEARS OF DATE OF CERTIFICATE ISSUE, CERTIFICATE EXPIRES AND BECOMES VOID. NO FUTURE CREDITS PERMITTED AFTER 5 YEARS FROM DATE OF ISSUE.

REDEEMING YOUR CERTIFICATE

To Redeem Your Certificate, You Must:

- a. Contact Reservations at: (This Certificate cannot be redeemed or used in any other manner, including but not limited to, at any travel agency.) b. Provide the following information to the contact above at time of redemption: (i) your name and contact information and (ii) the Certificate ID# on the face of Certificate and (iii) your choice of reservation dates.
- c. All guests on the booking must satisfy Three Forks Ranch's then current minimum age requirements.
 - 1. Three Forks Ranch will not, under any circumstances, pay a commission in connection with or related to the redemption and/or utilization of this "Certificate."
 - 2. Requested travel dates and room category may be capacity controlled and is subject to actual availability. Special Event dates may also be excluded, or require a supplement if chosen. Certificates may be upgraded at the Certificate holder's expense. Blackout dates may include but are not limited to the Month of November, Christmas and New Year's Weeks and all Three Forks Concert Weeks. Please note that all rooms are subject to availability.
- 3. By purchasing/redeeming this "Certificate," the purchaser/holder agrees to be bound by the following Three Forks Ranch cancellation terms and conditions: Booking/Cancellation Policy: Redemption of certificate considers your reservation as definite. If trip is cancelled 90+ days prior to arrival, full value of certificate will remain in place. If trip is cancelled 89-60 days prior to arrival, 50% of the value of certificate will remain in place unless a replacement client is found. After 60 days, no value associate with the certificate will remain in place unless a replacement client is found. Redemption of certificate with Three Forks Ranch or its agents is acknowledgement that redeemer has read and accepts cancellation and responsibility clauses.
- 4. Three Forks Ranch other policies and terms and conditions shall also apply. Minimum age for adult guests is 15 years old on the date of arrival. Children may be permitted when staying in the same room with at least one guest aged 18+.
- 5. Payments made for the "Certificate" are nonrefundable and cannot be redeemed for cash. Lost or stolen Certificates or Certificates used without permission will not be replaced. This "Certificate" has no cash value (\$0).
- 6. This "Certificate" is transferable only when gifted. This "Certificate" is void if sold for cash or other consideration. Any tax liability, connected with the receipt or use of this "Certificate" is the sole responsibility and liability of the person giving or receiving the Certificate; not Three Forks Ranch.
- 7. This Certificate shall be void where prohibited or restricted by law. Program is subject to change without notice. THIS CERTIFICATE IS NOT VALID FOR SALE TO CUSTOMERS LOCATED IN QUEBEC, CANADA AND PUERTO RICO.
