TERMS & CONDITIONS

WHAT'S INCLUDED IN THE CERTIFICATE:

1. During the Initial 2 Year Period

For a period of 2 years after the date specified on the front of the Certificate (the "Initial 2 Year Period"), the "Certificate" entitles the holder to book up to two guests in one stateroom. For all Certificate Levels, this Certificate also covers governmental taxes, fees and onboard gratuities.

The specific ships, categories and rivers for which the Certificate is valid varies depending upon what "level" of Certificate is purchased. Your Certificate "level" for your 7-night cruise is specified on the face of this Certificate. The Certificate cannot be used to pay for onboard incidentals or other expenses incurred by the guest, including, but not limited to retail purchases, bar beverages, spa services, etc.

Use for Non-Specified Cruise Ship, Destination or Length of Voyage
At the sole discretion of AmaWaterways, the Certificate may also be
applied toward voyages of different lengths other than noted on
the Certificate face (prices provided at time of booking). In the event
the Certificate is used towards a cruise other than those noted on the
Certificate face, the value of theCertificate reverts to the fixed dollar
amount of the Certificate at time of purchase. (For more details

Value amount shall be applied to the voyage selected and the redeemer must pay the difference in rate to AmaWaterways in full at the time of booking. If the Certificate is being used for a voyage that is covered by the Certificate but for an upgraded room category, the Value amount shall be applied and the redeemer must pay the difference in rate to AmaWaterways in full at the time of booking. In all cases, if the Value exceeds the rate for the specific voyage length, destination or stateroom category selected, the difference shall be forfeited.

This Certificate may be supplemented with other acceptable forms of payment toward stateroom upgrades and/or third and fourth guest additions, if applicable, and if ship/category occupancy allows.

The Certificate is valid on the AmaWaterways river cruise portion only and cannot be used to purchase other vacation experiences offered by AmaWaterways or by any other entity, whether affiliated with AmaWaterways or not. This Certificate cannot be used and is not applicable towards a room block that has been purchased by a third party and is then being resold, nor for a stateroom that is included as part of a group booking or full ship charter made with AmaWaterways. Other promotional or special event sailings may also be excluded.

2. After the Initial 2 Year Period

A. In lieu of the provisions of "1. During the Initial 2 Year Period", at any point after the end of the initial 2 year period for a certificate, the certificate shall be given a specific dollar value (based on the value of the certificate as specified by the cruise line in its annual pricing grid for certificates in effect at the time of purchase of the certificate, hereinafter the "Face Value"). That Face Value can be applied against the cost of any AmaWaterways cruise.

B. Payment of any outstanding balance. Any outstanding balance due after application of the Face Value must be paid in full at the time of the booking. If the Face Value exceeds the cost of the cruise, the difference shall not be refunded or credited.

REDEEMING YOUR CERTIFICATE

To Redeem Your Certificate, You Must:

other manner, including but not limited to, at any travel agency,
except for the Agency of Record (AmaWaterways) for the Certificate.

- c. All guests on the booking must satisfy AmaWaterways then current minimum age requirements.
 - AmaWaterways will not under any circumstances, pay a commission in connection with or related to the redemption and/or utilization of this Certificate.
 - Requested sailing dates and stateroom category may be capacity controlled and is subject to actual availability at time of redemption. Certificates may be upgraded at the Certificate holder's expense.
 - By purchasing redeeming this Certificate, the purchaser/holder agrees to be bound by all AmaWaterways cancellation terms and conditions.

The effective date of the cancellation is the date AmaWaterways receives cancellation notice. A change in sailing date, name changes, the substitution of a participant or a reduction in the number of guests in a stateroom are treated as a cancellation in that all applicable cancellation charges apply. All other cancellation charges are per-person, based

on the cancellation date, as seen in the chart on AmaWaterways' website: www.amawaterways.com/terms-conditions. Cancellations received within the period applicable to your cruise, you will receive a credit against a future AmaWaterways cruise in the amount equal to the face value of the cruise minus the applicable cancellation charges. No cash refunds will be provided. Any penalties assessed for vacation experiences offered by another entity in conjunction with the AmaWaterways cruise will be assessed from any monies paid and will not be covered by the value of the certificate.
