# TERMS & CONDITIONS

## WHAT'S INCLUDED IN THE CERTIFICATE:

For a period of 18 months after the issue date specified on the front of the Certificate, the "Certificate" entitles the holder to book one room for two guests for the specific length of stay, and room category specified on the face of this Certificate. This Certificate also covers all resort taxes and fees, plus a nightly resort credit.

Resort credit can be applied towards any food, beverage, spa or retail outlet located on property that allows for a charge back to the room folio. Unused resort credits are non-refundable.

## Use for Non-Specified Length of Stay or Room Category

At the sole discretion of St. Kitts Marriott Resort, the Certificate may also be used for stays of different lengths, upgraded room categories, or accommodations for more guests other than noted on the "Certificate" face (rates provided at time of booking). In the event the "Certificate" is used for any modification other than noted on the "Certificate" face, the value of the Certificate reverts to the fixed dollar amount of the Certificate at time of purchase (at the discretion of St. Kitts Marriott Resort). The value will be applied to the reservation and the redeemer must pay the difference in rate in full to St. Kitts Marriott Resort at the time of booking. In all cases, if the Value exceeds the requested modification, the difference shall be forfeited. St. Kitts Marriott Resort at the time of the booking request will provide the lowest fare publicly available for which the redeemer qualifies, including available promotional rates unless otherwise expressly provided in the terms and conditions for that promotion.

The Certificate cannot be used to purchase stays offered by any other entity, whether affiliated with St. Kitts Marriott Resort or not. This "Certificate" cannot be used and is not applicable towards a room block that has been purchased by a third party and is then being resold, nor for a room that is included as part of a group booking or full resort buyout made with St. Kitts Marriott Resort.

## REDEEMING YOUR CERTIFICATE

*To Redeem Your Certificate, You Must:*

- a. Contact the Reservations Director at XXX-XXX-XXXX. (This Certificate cannot be redeemed or used in any other manner, including but not limited to, at any travel agency.) **Please provide your legal first and last name, Certificate ID#, and Room Type from the face of this certificate, and your preferred dates of travel.** Please also advise the reservations agent of any desired upgrades at the time of booking (higher room category, longer length of stay, additional # of room guests).
- b. All guests on the booking must satisfy St. Kitts Marriott Resort's then current minimum age requirements.
  1. St. Kitts Marriott Resort will not, under any circumstances, pay a commission in connection with or related to the redemption and/or utilization of this "Certificate."
  2. **Requested travel dates and room category may be capacity controlled and is subject to actual availability.** Certificates may be upgraded at the Certificate holder's expense. January 10-31, 2026, and June 24-27, 2026 are blackout dates for this Certificate. Additional blackout dates may apply.
  3. By purchasing/redeeming this "Certificate," the purchaser/holder agrees to be bound by the following St. Kitts Marriott Resort's cancellation terms and conditions: **For reservations made and cancelled within 7 days of arrival, full credit will be applied to a new booking. If cancelled less than 7 days prior to guest arrival, it will result in 1 night room rate penalty from a future credit. All NO SHOWS will receive no future credit. No cash refunds issued at any point in time.**
  4. St. Kitts Marriott Resort's other policies and terms and conditions shall also apply. Minimum age for guests is 18 years old on the date of arrival. Children are permitted when staying in the same room with at least one guest aged 18+.
  5. Payments made for the "Certificate" are nonrefundable and cannot be redeemed for cash. Lost or stolen Certificates or Certificates used without permission will not be replaced. This "Certificate" has no cash value (\$0).
  6. This "Certificate" is transferable only when gifted. This "Certificate" is void if sold for cash or other consideration. Any tax liability, connected with the receipt or use of this "Certificate" is the sole responsibility and liability of the person giving or receiving the Certificate; not St. Kitts Marriott Resort.
