TERMS & CONDITIONS

WHAT'S INCLUDED IN THE CERTIFICATE:

1. During the Initial 1 Year Period

For a period of 1 year after the date specified on the front of the Certificate (the "Initial 1 Year Period"), the "Certificate" entitles the holder to book two guests in a double occupancy room. For all Certificate Levels, this Certificate also covers governmental and quasi-governmental taxes, resort/service fees.

The Certificate cannot be used to pay for incidentals or other expenses incurred by the guest, including, but not limited to, tours, hotel/resort purchases, bar beverages, gaming, or spa services.

Certificate Includes: XXX nights accommodations, XXX Golf or Spa Resort Credit. Subject to availability.

Use for Non-Specified Resort or Length of Stay

At the sole discretion of Tee Times USA, the Certificate may also be used for resort stays of different lengths than noted on the "Certificate" face (prices provided at time of booking). In the event the "Certificate" is used towards a resort other than the list of resorts noted on the "Certificate" face, the value of the Certificate reverts to the fixed dollar amount of the Certificate at time of purchase. For more details, contact Tee Times USA. That Value amount shall be applied to the resort selected and booked and the redeemer must pay the difference in rate to Tee Times USA at the time of booking. If the Certificate is being used for a resort and length of stay that is covered by the Certificate but for an upgraded room category, the Value amount shall be applied and the redeemer must pay the difference in rate to Tee Times USA at the time of booking. In all cases, if the Value exceeds the rate for the specific resort and room category selected, the difference shall be forfeited. Tee Times USA at the time of the booking request will provide the lowest fare publicly available for which the redeemer qualifies, including available promotional rates unless otherwise expressly provided in the terms and conditions for that promotion.

This "Certificate" may be supplemented with other acceptable forms of payment toward room upgrades and/or 3rd and 4th guest additions.

The Certificate cannot be used to purchase resorts offered by any other entity, whether affiliated with Tee Times USA or not. This "Certificate" cannot be used and is not applicable towards a room block that has been purchased by a third party and is then being resold, nor for a room that is included as part of a group booking or full resort buyout made with Tee Times USA.

2. After the Initial 1 Year Period

A. IN LIEU OF THE PROVISIONS OF "1. During the Initial 1 Year Period", AT ANY POINT AFTER THE END OF THE INITIAL 1 YEAR PERIOD FOR A CERTIFICATE, THE CERTIFICATE SHALL BE GIVEN A SPECIFIC DOLLAR VALUE (BASED ON THE FACE VALUE OF THE CERTIFICATE AS SPECIFIED BY THE RESORT IN ITS ANNUAL PRICING GRID FOR CERTIFICATES IN EFFECT AT THE TIME OF PURCHASE OF THE CERTIFICATE (hereinafter the "Face Value"). THAT FACE VALUE CAN BE APPLIED AGAINST THE COST OF ANY PURCHASE AT TEE TIMES USA EXCLUDING GIFT CERTIFICATES.

B. PAYMENT OF ANY OUTSTANDING BALANCE.

ANY OUTSTANDING BALANCE DUE AFTER APPLICATION OF THE FACE VALUE MUST BE PAID AT THE TIME OF THE BOOKING. IF THE FACE VALUE EXCEEDS THE COST OF THE RESORT STAY, THE DIFFERENCE SHALL NOT BE REFUNDED OR CREDITED.

REDEEMING YOUR CERTIFICATE *To Redeem Your Certificate, You Must:*

a. This Certificate cannot be redeemed or used in any other manner, including but not limited to, at any travel agency.

b. Provide Tee Times USA with: (i) your booking number; and (ii) the certificate ID# on the face of Certificate.

c. All guests on the booking must satisfy Tee Times USA's current minimum age requirements.

1. Tee Times USA will not, under any circumstances, pay a commission in connection with or related to the redemption and/or utilization of this "Certificate."

2. Requested travel dates and room category may be capacity controlled and is subject to actual availability. Certificates may be upgraded at the Certificate holder's expense. Travel dates are subject to availability.
