# Terms & Conditions

## What's Included in the Certificate:

### 1. During the Initial 1 Year Period

For a period of 1 year after the date specified on the front of the Certificate (the "Initial 1 Year Period"), the "Certificate" entitles the holder to book two guests in a double occupancy room. For all Certificate Levels, this Certificate also covers governmental and quasi-governmental taxes, resort/service fees and a 1-Year Club Med Membership, in addition to gratuities.

The specific resorts for which the Certificate is valid vary depending upon what "level" of Certificate you purchased.

Your Certificate "level" and the length of stay covered is specified on the face of this Certificate. The Certificate cannot be used to pay for incidentals or other expenses incurred by the guest, including, but not limited to, tours, hotel/resort purchases, bar beverages, spa services or addition of kids.

### Use for Non-Specified Club Med Resort or Length of Stay

At the sole discretion of Club Med, the Certificate may also be used for resort stays of different lengths than noted on the "Certificate" face (prices provided at time of booking). In the event the "Certificate" is used towards a resort other than the list of resorts noted on the "Certificate" face, the value of the Certificate reverts to the fixed dollar amount of the Certificate at time of purchase. For more details, contact Club Med reservations at 1-800-CLUB MED. That Value amount shall be applied to the resort selected and booked and the redeemer must pay the difference in rate to Club Med at the time of booking. If the Certificate is being used for a resort and length of stay that is covered by the Certificate but for an upgraded room category, the Value amount shall be applied and the redeemer must pay the difference in rate to the Club Med at the time of booking. In all cases, if the Value exceeds the rate for the specific resort and room category selected, the difference shall be forfeited. Club Med at the time of the booking request will provide the lowest fare publicly available for which the redeemer qualifies, including available promotional rates unless otherwise expressly provided in the terms and conditions for that promotion.

### 2. After the Initial 1 Year Period

A. IN LIEU OF THE PROVISIONS OF "1. During the Initial 1 Year Period", AT ANY POINT AFTER THE END OF THE INITIAL 1 YEAR PERIOD FOR A CERTIFICATE, THE CERTIFICATE SHALL BE GIVEN A SPECIFIC DOLLAR VALUE (BASED ON THE FACE VALUE OF THE CERTIFICATE AS SPECIFIED BY THE RESORT IN ITS ANNUAL PRICING GRID FOR CERTIFICATES IN EFFECT AT THE TIME OF PURCHASE OF THE CERTIFICATE (hereinafter the "Face Value"). THAT FACE VALUE CAN BE APPLIED AGAINST THE COST OF ANY CLUB MED RESORT.

B. PAYMENT OF ANY OUTSTANDING BALANCE. ANY OUTSTANDING BALANCE DUE AFTER APPLICATION OF THE FACE VALUE MUST BE PAID AT THE TIME OF THE BOOKING. IF THE FACE VALUE EXCEEDS THE COST OF THE RESORT STAY, THE DIFFERENCE SHALL NOT BE REFUNDED OR CREDITED.

## Redeeming Your Certificate

To Redeem Your Certificate, You Must:

Contact Club Med. Once you have your Reservation File Number, enter it in the "Reservation File#" field, then submit your certificate via email (scan or photo accepted) to [Claudia.gil@clubmed.com](mailto:Claudia.gil@clubmed.com), so that your gift certificate can be applied to your reservation. This Certificate cannot be redeemed or used in any other manner, including but not limited to, at any travel agency.

All guests on the booking must satisfy Club Med then current minimum age requirements. For Turkoise all guests must be at least 18 years of age. For Columbus Isle, all guests must be at least 2 years of age.

1. Club Med will not, under any circumstances, pay a commission in connection with or related to the redemption and/or utilization of this "Certificate."
2. Requested travel dates and room category may be capacity controlled and is subject to actual availability. Certificates may be upgraded at the Certificate holder's expense. Blackout dates include Thanksgiving, Christmas and New Year's, President's Week, and Easter/Passover.
3. By purchasing/redeeming this "Certificate," the purchaser/holder agrees to be bound by all Club Med cancellation terms and conditions. This certificate is non-refundable. Once certificate is redeemed and booking confirmation issued to certificate recipient, the approval for any requested change to the booking (change in arrival date, # of nights, accommodation type), etc.) is at the discretion of Club Med. No monies will be issued to the certificate purchaser or recipient should the booking be cancelled at any point in time after the initial redemption of certificate.
4. Club Med other policies and terms and conditions shall also apply.
5. Certificate includes the essential 1-year Club Med Membership Fee, which is a basic Travel Protection Plan. Optional upgraded plan is available at an extra cost.
6. "Certificate" is nonrefundable and cannot be redeemed for cash. Lost, stolen or damaged Certificates or Certificates used without permission will not be replaced. This "Certificate" has no cash value.
7. This "Certificate" is transferable only when gifted. This "Certificate" is void if sold for cash or other consideration. Any tax liability, connected with the receipt or use of this "Certificate" is the sole responsibility and liability of the person giving or receiving the Certificate; not Club Med.
8. This Certificate shall be void where prohibited or restricted by law. Program is subject to change without notice.

## Expiration and Charges

Your Club Med Certificate has no expiration date and does not expire. This Certificate has neither an inactive or dormancy fee nor any monthly or other maintenance fee.
